ORDER N° CONCERNING THE LAUNCHING OF THE COMPETITIVE ENTRANCE EXAMINATION INTO THE FIRST YEAR OF THE BACHELOR'S DEGREE PROGRAMME IN THE FIELDS OF STUDY, DIGITAL ARTS AND DIGITAL HUMANITIES AT THE NATIONAL ADVANCED SCHOOL OF ENGINEERING (NASE) OF THE UNIVERSITY OF YAOUNDE I, AND TO FIX THE NUMBER OF PLACES AVAILABLE FOR THE 2019/2020 ACADEMIC YEAR.

## HEREBY ORDERS AS FOLLOWS:

Faculties, Schools and Institutes of Cameroon State Universities for 2019-2020 academic year.

Article 1: (1) A competitive entrance examination for the admission of twenty (20) students into the first year of the bachelor's degree in engineering science, in the field of Digital Arts, and twenty (20) students into the first year of the bachelor's degree in engineering science, in the field of Digital Humanities, at the National Advanced School of Engineering (NASE) of The University of Yaounde I, has been launched for the 2019/2020 academic year, in the following centres: Bafoussam, Bamenda, Bertoua, Buea, Douala, Ebolowa, Garoua, Maroua, Ngaoundere, Yaounde and in the capitals of CEMAC Countries.

(2) The examination will consist of one (01) written paper in Mathematics and one (01) written paper in general knowledge of ICTs and society, two (02) for each paper and of equal rating.

Article 2: The competitive entrance examination is open to:

- Final year students of the Baccalaureate in any series and candidates preparing for the General Certificate of Education Advanced Level (GCE-AL) in any series provided that they have passed in at least four subjects (Religious Knowledge excluded) at the GCE-OL in one sitting.
- Holders of the Baccalaureate in any series or at least two GCE-AL papers except Religious Knowledge, obtained in one sitting, or any other equivalent certificates recognised by the Ministry of Higher Education.

Article 3: (1) The syllabus for the examination is made up of the common areas of the programmes of the Lower and Upper Sixth classes or the *Premières* and *Terminales* classes of the French Sub System.

(2) There will be no oral examination.

Article 4: Registered candidates who are awaiting the results of the above mentioned certificate examinations shall only be admitted to the NASE if successful in the competitive entrance examination, on presentation of an attestation of success or the original result slip of the certificate obtained in 2019, within the deadline set by the school, before registration into the NASE.

<u>Article 5:</u> Registration for the competitive examination is done online through the website of the NASE <a href="http://www.polytechnique.cm/concours">http://www.polytechnique.cm/concours</a>:

The application files shall include the following documents:

- An individual form duly filled by the candidate, online on the web site of entrance examination of the school: http://www.polytechnique.cm/concours
- A photocopy of the national identity card or its receipt.
- 3. Transcripts for Lower and Upper Sixth forms or *Première* and *Terminale* where applicable.
- 4. A certified true copy of the birth certificate (not more than three months old).
- A certified true copy of the Baccalaureate / GCE-A/L in two subjects (Religious knowledge excluded) or equivalent certificate recognised by the Ministry of Higher Education or an Attestation of success of any of the above.
- •6. Transcripts of the Probatoire and Baccalaureate or Form five (GCE-O/L class) and Upper Sixth (GCE-A/L class) whichever is applicable.
- 4 passport size photographs (4 x 4)
- A medical attestation of physical fitness delivered by a State registered medical doctor.
- 9. An A4 (400) francs CFA stamped self-addressed envelope.

<u>Article 6:</u> The examination fee of twenty thousand francs CFA (20.000 frs) shall be payable only through EXPRESS UNION with a receipt delivered in exchange. The receipt shall be attached to the candidate's application file. The examination fee which is non-refundable shall be used in covering expenses related to the organisation of the examinations. Any other means of payment shall not be accepted.

<u>Article 7:</u> The complete application files shall reach the Admissions Office of The National Advanced School of Engineering, P.O. 8390 Yaounde, or the Regional Delegation of The Ministry of Secondary Education of their residence **latest the 05<sup>th</sup> of July 2019.** However, foreign candidates of countries in the CEMAC Zone shall deposit their files with the Cameroonian diplomatic representatives in their respective countries.

<u>Article 8</u>: Only candidates who have submitted complete application files within the deadline will be called upon to write the exams. They are therefore requested to come along with their **National Identity Cards** which must be presented to the examination authorities.

Article 9: Candidates for the entrance examination into the first year must not be above 25 years by the 1st of January 2018.

Article 10: The examination will take place on the 10th and 11th of July 2019 in the centres indicated above.

<u>Article 11</u>: The Rector of the University of Yaounde I, the Director in the Department of University Accreditations and Quality, and the Director of the National Advanced School of Engineering of The University of Yaounde I, each in his own sphere, are responsible for the implementation of this circular which shall be registered and published in English and French wherever necessary./-
